# **MAY HOLIDAYS**

## **SPEEDING/PARKING IN STREET**

This is a reminder to Tuscany residents and guests . . . the speed limit on our streets is **15 mph**. Please be observant and careful to avoid causing an accident that might involve a child or another vehicle by always watching your speedometer as you drive through Tuscany.

A recent incident was reported where a car parked in the street was sideswiped by another vehicle. With larger delivery and work trucks, moving vans, etc., frequently driving through Tuscany, it is a risk you take when you park in the street. Please use driveways as much as possible for parking additional vehicles.

Because there is limited space in our neighborhood parking in the street can cause an obstruction of sightlines for other drivers in addition to possibly resulting in damage to a parked vehicle. And also remember that it is illegal to block a sidewalk or a mailbox! Just be aware . . . and be considerate.

<u>Parents</u>: While drivers need to be extra vigilant to watch for children darting into the streets, parents need to continually remind their children that streets (including cul-de-sacs) are for motor vehicles and should not be used as a playground. Please caution your children to be mindful of traffic when they are riding bikes or playing in or near the streets. It only takes a second to be the victim of an accident. No one wants to see that happen.

With the onset of summertime weather and children out of school during the daytime, they will be playing outdoors more. All residents should be aware that children are allowed to play in the vacant, grassy areas within Tuscany (HOA property), on sidewalks, and in their own yards. However, children should also be respectful of their neighbors' properties and avoid trespassing in the yards and driveways of other people unless specifically invited.



# **DOOR-TO-DOOR SALES SOLICITATIONS**


Have you recently had a salesperson come to your door claiming to "be working at one of your neighbors?" They then quickly transition into their sales pitch for solar panels, pressure washing, etc.

Residents of a community with posted **NO SOLICITATION** signs have the right to ask door-to-door solicitors to observe that notice and leave the neighborhood. If they don't leave, law enforcement can be called; however, these types of calls will not be considered a priority by police.

Respectfully tell door-to-door salespeople that they're not to walk through the neighborhood knocking on doors or ringing doorbells. But most companies will disregard that request, so it's difficult to control. One problem is when the company representative claims they are contacting their own customers. We can tell them they can go to those designated doors but nobody else's, and 9 out of 10 times they'll comply.

According to Jennifer Conti, property manager at McNeil Management Services, "homeowners need to take a stance and not open the doors to solicitors. It is a number game to them and as long as homeowners are opening their doors, listening to their pitch, or purchasing their products, they will continue. Any homeowner can call the company themselves and report solicitors on their property. If someone feels unsafe, threatened, or harassed, it would be the responsibility of the homeowner to contact law enforcement and make a report."

If you do open the door and a sales pitch is initiated, simply advise the person that Tuscany has **NO SOLICITATION** signs posted beside the gates at each of the three entrances. You can advise them that the police could be called, and it will cause problems for their company and them as individuals who are trespassing where not invited.



### **GATE PASSAGE ISSUES**

Tailgating — in the context of a gated property — refers to an unauthorized vehicle that follows a resident or another authorized individual so closely that they can pass through the gate while it remains open.

Also called "piggybacking," tailgating is a serious security breach — though not all tailgating has malicious intent. People often tailgate during busy times of the day to reduce their wait time as cars await entry at the gate. In other cases, it's just an authorized resident who tailgates because they forgot their gate fob or do not wish to stop and take the time to enter the gate code. It might even be a resident's guest following the resident to their home in a separate vehicle.

Besides possibly causing a safety problem for residents, it is best to try and prevent it altogether. It can create a negative reputation for the community caused by a perception that it's unsafe to live in Tuscany because "anyone can just tailgate and gain access" to the neighborhood. In addition, physical damage to the gate can result, thereby resulting in costly repairs.

#### FLORIDA NUISANCE ALLIGATOR HOTLINE

It is mating season for alligators, and they are occasionally moving from pond to pond in Tampa Palms. Just give them space and do not approach them. Depending on their size and whether they pose a threat, there is a contact office with the Florida Wildlife Commission for nuisance alligators.


#### What is a nuisance alligator?

Generally, an alligator may be considered a nuisance if it's at least 4 feet in length and believed to pose a threat to people, pets or property. If you're concerned about an alligator, call the Nuisance Alligator Hotline at 866-FWC-GATOR (866-392-4286), and they will dispatch a contracted nuisance alligator trapper to resolve the situation.



Alligators less than 4 feet in length are not large enough to be dangerous to people or pets, unless handled. You should never handle an alligator, even a small one, because alligator bites can result in serious infection and it's illegal. If there's an alligator under 4 feet in your swimming pool, on your porch, or in a similar menacing situation, call the Nuisance Alligator Hotline at 866-FWC-GATOR (866-392-4286).
