### **2021 ANNUAL HOMEOWNERS MEETING**

The annual homeowners meeting was held on November 10 at Lifesong Church. Disappointingly, a sufficient number of interested homeowners were not present, or did not submit a proxy, to constitute a quorum in order that the election of a new HOA Board for 2022 could be conducted. There were 23 voting homeowners present at the meeting, and 15 proxies were received for a total of just 38 homeowners responding to a well-advertised meeting date/place/time. Based on the number of homes (198) in Tuscany, 60 votes, whether in person or by proxy, are required for a quorum in order to conduct an election. The current HOA Board will continue to serve until the next annual homeowners meeting in 2022

Instead of an official Board meeting and election, President Kevin Hawley opened up the meeting for an informal Q&A session to respond to questions, concerns, and to update those in attendance concerning several issues currently being addressed within our community. Topics discussed included individual property landscaping maintenance, pond maintenance, gate maintenance, repaving of Tampa Palms Boulevard, speeding within Tuscany, and blocking of sidewalks by vehicles.

Since April a new company has been hired to monitor and maintain the ponds within Tuscany. Solitude Lake Management will now be managing the ponds within Tuscany.

After comparison bids were obtained/reviewed by the Landscaping Committee from several property maintenance companies, Nature Coast has been hired to continue maintenance of common and individual properties for the coming year. Weeding of individual properties' landscaped beds has been added to the new contract with Nature Coast.

**NOTE**: Improvement in overall appearance of the neighborhood has resulted from the recent spreading of pine bark mulch by Nature Coast. Let's all work to keep the 'hood looking good during the coming year!!

# TAMPA PALMS BOULEVARD UPDATE



The Tampa City Council has voted to repave Tampa Palms Boulevard (TPB) in 2022. The initial proposal to reduce TPB to one driving lane and one bicycle lane has been discarded after input from Tampa Palms residents. Brandie Miklus, the city's infrastructure and mobility program coordinator, has indicated that the TPB improvements will include resurfacing, multimodal and safety improvements, traffic calming, enhanced crosswalks with Rectangular Rapid Flashing Beacons (RRFBs), and separated bicycle lanes.

All large boxes to be recycled should be broken down and placed inside the blue recycle bin. <u>Empty boxes placed on the ground beside the bin **will not** be picked up</u>. Drivers do not exit trucks to pick up items that are not placed inside the bin.

Trash bins should not be left in driveways or curbside after the trash has been picked up on Mondays and Thursdays. Please return the bins to your garage as soon as possible after pickup has been completed.

The speed limit on Tuscany's streets is 15 mph. Some drivers are continuing to exceed that speed limit, which can endanger pedestrians or children at play. Please ensure that everyone in your family and your guests are aware of the speed limit and observe it.

Also, please advise any visitors or workers at your home that sidewalks should not be blocked with their vehicles for safety reasons. Violators may find their vehicles have been towed.

As a safety precaution, garage doors should remain closed unless work is being done in the immediate area inside the garage or outside your home.

#### JUNK DUMPING



A few weeks ago, Nature Coast cleaned up this traffic island on Bella Woods Drive in order that both vehicles and pedestrians' vision would not be blocked by the palmettos. They uncovered the birdfeeder pole shown above which someone thoughtlessly tossed into the thick undergrowth.

The traffic islands, ponds, and conservation areas surrounding our homes **ARE NOT** to be used as dumping grounds. If you have something that needs to be disposed of, please do it properly. Since items like this cannot be placed in the gray garbage bins or the recycling bins, they should be taken to a city junk collection site, not deposited on community or individual property in Tuscany. Use the Community Collection Center at 8001 W. Linebaugh Avenue or call independent companies that will pick up junk, such as 1-800-GOT-JUNK, Dump Squad Junk Removal, Dump My Junk, etc. <u>From the city of Tampa website</u>: Illegal dumping is more than just an eyesore; it is a criminal offense. It depreciates property values. The cost of collecting illegal dumping affects every citizen of the city.

If you witness an illegal dumping in progress, call the Tampa Police non-emergency number at (813) 231-6130. After the Police Department has responded, call the Department of Solid Waste & Environmental Program Management at (813) 348-1146 for collection of the debris if it is on city of Tampa right of way. If the illegal dumping occurred on private property, report it to a Solid Waste Inspector at (813) 274-5545.



### HAVE YOU NOTICED??

Several homeowners have recently had their homes repainted, which truly helps to improve the appearance of the neighborhood as a whole. **THANK YOU!!** 

If your home has faded paint or stucco cracks, then it is time to get it repainted. Stucco cracks can provide a pathway for moisture and water to enter into a wall system. Once moisture or water gets inside a wall, it will inevitably cause further damage. Once cracks are repaired, then painting can be done followed by a clear sealer to protect the paint.

Approved paint color schemes for Tuscany homes can be found on the HOA website (<u>www.TuscanyTampaPalmsHOA.com</u>). Once a color decision is made, then an Alteration Application should be filed with McNeil Management Services so that the Architectural Review Committee (ARC) can review the application and approve the painting or request additional information from the homeowner(s). The Alteration Application form can be found on the website, too.



### **COYOTES IN TAMPA PALMS**

With the development of a new apartment complex on the north end of Tampa Palms Boulevard near Tuscany, wildlife has been displaced as their natural habitat has been destroyed. Several residents of Tampa Palms have recently observed coyotes moving into various neighborhoods as a result.

Please be super careful that any pets are not allowed to roam outdoors unsupervised and without a leash. If the coyotes are hungry, they can quickly and easily kill small animals such as cats and dogs. Humans can also be vulnerable to coyote attacks. When walking your pet, it is recommended that you take some sort of noise maker with you in case you encounter a coyote.

#### **NEW TELEPHONE DIALING PROCEDURE**

Frontier Communications has issued a statement in customer bills concerning upcoming changes to dialing procedures for landline phones.

Effective January 22, 2022, customers with a Florida 813 Area Code <u>must</u> dial the Area Code + telephone number for local calls. Customers can begin using the new dialing procedure now, but no later than January 22.

To ensure a continuing supply of telephone numbers, the 656 Area Code is being added to the area served by the 813 Area Code.
